Next time we will give race instructions before moving to the street, or adjust the start location. There was some confusion about the route at Kailua Park. Course marshals need to know where runners should cross the road.
- C. Windward Half Marathon & 5K Ron/Joan. There are plenty of volunteer opportunities, in particular, the set up at 4 am needs workers. We will rent two trucks/vans. will drive one. The checklist is attached.
- D. Socks instead shirts proposal Sam. Socks with our logo can be purchased for \$4.50 per pair and may be an interesting alternative to shirts. A motion was made to purchase 200 pairs of logo socks in various sizes (and colors if available). We can use these for SAM's 5K and sell extras. Motion carried.

- V. New Business

 - B. Lanikai Joyce Cassen is moving to the mainland and 2018 will be the last race she and Norm will sponsor. It was suggested that we ask **sponsors** if he is interested in sponsoring the race. Kit already sponsors the Mango Days 5K in memory of his daughter.
 - C. Chapson The cost of police was too high for the number of entrants. It was suggested that we explore a Hawaii Kai or a Schofield route.
 - D. 10-miler Can we get on Schofield? will talk to Morale Welfare Recreation and to Joe Washington of USATF, who is army.
 - E. Susie Steffan RRCA coach runs Windward Training Freaks on Tuesdays at Kailua High School, and wants to affiliate with Club. She is not for profit. A motion was made to have a subcommittee to clarify expectations, including not profiting, use of logo, insurance, etc.

- F. Medals We have enough for the next few races. Purchasing 224 ribbons and 314 medals for future needs will cost \$593.86. A motion was made to purchase these. Motion carried.
