
Mid-Pacific Road Runners Executive Committee Meeting Minutes April 17, 2018 – Room 219

- D. Pacific Gateway Center 5K Sam
 - -Mission is to help immigrants and low income residents; they have offered \$500-1,500 for a race director. PGC will do most of the work if our fee is at the low end. If high end fee, the race director would do most of the work. PGC will get their own insurance. Start and finish at the Kakaako pump station (across Gold Bond building) which has been renovated as a senior center. Race date should be later this year or early next year. Possible course from pump station towards Ala Moana park to Atkinson and back. Timeline is donating timing services (is on the BOD). They could get donations, provide volunteers, design and order shirts, provide tables/tents; market the race, etc.
 - -We could offer to charge \$1,000 and modify proposed "to-do" list.
 - -Possible to replace the SAM's 5K with the PGC 5K. We should consider what to do with the SAM plaque if race is displaced or discontinued.
 - -Approved to have a subcommittee of our Board meet with their subcommittee to work out the agreement and bring back to both Boards for approval.
