IV. Committee Reports

A. Race Committee – Ron Alford

1. Gateway Center's 5K for Kupuna (Nov. 25)– Kawika Carlson, race director
  - [REDACTED] will handle permits and contact the neighborhood board, the Gold Bond Bldg., and Kewalo Basin.
  - Bib numbers – [REDACTED] will ask if they want something special or if those printed by Sam are ok.
  - Volunteers – We will handle registration, PGC will handle all others – [REDACTED] will confirm
  - Promotion – We will print flyers and distribute, both organizations will put up on social media, we will arrange for an ad in the Sept/Oct edition of Hawaii Sport Magazine. All promotion costs will be passed on to PGC.
  - Course Map – not necessary for this event.
  - Race co-director not necessary since many of us will assist [REDACTED]

2. Running Cruise Event Update (Sept. 15) – Joy Schoenecker, race director
  - Lanyards of differing colors to identify groups priced at \$120. There will be 6 groups with two leaders each (1 lead, 1 sweep) of varying paces with less than 180 participants.
  - Shave Ice Truck priced at \$200-300. Will need 2 parking spaces reserved for the truck on the morning of the event.
  - Runners will walk from their hotel to the start (surfer statue on Kalakaua at the beginning of the beachwalk). Runners will be sent off in groups about 2-3 minutes apart. First stop will be near the Natatorium, second stop at the lighthouse on Diamond Head, turnaround point at the Amelia Earhart monument on Diamond Head possibly with a water stop, return to Kapiolani Park with the finish near the carriage road behind the bandstand.
  - MPRRC tent and tables to be set up in the area between the carriage road and the restrooms. [REDACTED] will determine if a reservation is necessary for that area.
  - Refreshments will be made available at the tent (water, drinks, etc.) as well as malasadas if we can get them donated.
  - [REDACTED] will follow-up with [REDACTED] regarding when the club will be paid for expenses.
  - [REDACTED] will look into getting a hula dancer for the post-race festivities.
  - Action by the Board:  
The Board approved spending \$120 for lanyards and \$200-300 for a Shave Ice Truck.

3. Race Recap

  - Went well.
- b. Lanikai 8K – J.B. Nation & Joan Davis, race directors
  - Went well, except not enough blue ribbons and no check signers.

4. Upcoming Races

- a. Old Pali Road – Betty Gail Alford, race director
  - [REDACTED] to make arrangements with Paradise Lua or another vendor for portable toilets. They do not provide locks anymore; we must provide those ourselves.
  - [REDACTED] will order trophies and have them delivered to [REDACTED] house.
  - [REDACTED] will arrange to get the keys to open the gates.
  - [REDACTED] has volunteered to pick up the equipment for the race, man the water station, and return the equipment after the race.

- b. Tantalus – Joan Davis, race director  
Permits OK. [REDACTED] will follow-up with [REDACTED], Principal, regarding parking, placement of the port-a-potties, and school involvement.
- c. Bosetti 10K – Kawika Carlson and Joy Schoenecker, race directors  
Tuesday, January 1, 2019, Bosetti 10 K, 7 am, Kealahou Street, Hawaii Kai.
- d. Bob & Ron’s 5K – Joan Davis, Judith Inazu, and Craig Knohl, race directors. Sunday, January 6, 2019, 7 am, Noelani School, Manoa
- e. Chapson 8K - Sunday, January 20, 2019, 7 am.  
Koko Head District Park is not a viable option due to baseball tournaments that day. Kaiser High School was suggested but [REDACTED] indicated that permission is likely not forthcoming.
- f. Faerber 10K –Sunday, February 3, 2019, 7 am, Kapiolani Park.  
If the Holiday 5K is discontinued, the committee recommends presenting the Silvia A. Martz trophy at this race.
