Amendment to Storage Locker Delivery Service Contract

This Amendment is made to the Storage Locker Delivery Service Contract ("Contract") between Mid-Pacific Road Runners Club ("Client") and Craig Knol ("Service Provider") effective as of [Date].

- **1. Additional Compensation for Larger Deliveries:** When the Service Provider is required to use his delivery van for larger deliveries, he will be compensated at a rate of \$250. This includes, but is not limited to, Expos where the Service Provider is asked to bring all club merchandise to sell.
- **2. Cancellation Clause:** In the event that a scheduled delivery is canceled within 48 hours of the scheduled delivery time, the Service Provider shall be paid in full for the scheduled delivery.

All other terms and conditions of the original Contract remain in full force and effect.
